# Wilmette Park District Policy for Public Comment

The Board of Park Commissioners, in its regular or special meetings, is a deliberative body assembled to make decisions on new and pending matters affecting the District. Park Board and Committee meetings are meetings held in public, not a public meeting. The Board invites both oral and written communications from its residents.

To facilitate the conduct of Board/Committee meetings, the following procedures will be followed:

- 1. A section of each regular meeting is set aside for public comment and will be noted on the agenda as "Recognition of Visitors."
- 2. During the "Recognition of Visitors" agenda item, audience members should raise their hands and be recognized by the President/Chairperson prior to speaking.
- 3. When recognized by the President/Chairperson, each audience member should identify themselves and limit speaking to no more than three (3) minutes, unless additional time is granted by the President/Chairperson.
- 4. Questions are to be directed to the entire Board/Committee.
- 5. Park Board members may, by addressing the President/Chairperson, interrupt a presenter to obtain clarification and/or further information.
- 6. A Board/Committee meeting is not a forum for complaints against individual employees. Such matters are handled by directly contacting the Executive Director. Complaints against the Executive Director should be handled by directly contacting the President of the Board of Park Commissioners.
- 7. During presentation and discussion of agenda items, the President/Chairperson will not recognize speakers in the audience unless the Board/Committee desires additional information from an audience member.
- 8. When addressing the Board/Committee, all persons permitted to speak shall confine their remarks to the matter at hand and avoid personal remarks, the impugning of motives, and merely contentious statements. If any person indulges in such remarks or otherwise engages in conduct injurious to the civil discourse of the Board/Committee and the meeting, the President/Chairperson may immediately terminate the opportunity to speak. This decision is at the discretion of the President/Chairperson or upon the affirmative vote of two-thirds (2/3) of the park board commissioners present.
- Any person, except a member of the Board, who engages in disorderly conduct during a meeting, may be ejected from the meeting upon motion passed by a majority of the Board present.

**Subject: [external] Concern About Wilmette Beach Safety** 

This past weekend, one person drowned at an Evanston beach, and three others had to be rescued. I'm concerned that the same thing could easily happen in Wilmette -- because the swimming ban and other safety rules are not being sufficiently enforced.

The Wilmette beaches (and roadways) used to be safe. The beaches were generally uncrowded, and the rules were generally followed. But last year, when most area beaches were closed, people discovered Wilmette's beaches. The crowds moved in. This year, the crowds discovered that rules at Wilmette's beaches aren't enforced – and the crowds responded by breaking rules with abandon.

This is particularly true at South Beach. The single person hired to regulate parking on Harbor Drive couldn't keep up with the steady flow of scofflaw cars. The young staff that tried to enforce no swimming rules were largely ignored. People routinely used unregistered SUPs once the word got out that you could launch from South Beach for free. Dog owners let their dogs run loose even after being asked to keep the dogs on leash. Most concerning, little kids, often unsupervised, were allowed to use blow-up floats in the water.

The other two beaches were better patrolled. But even there, non-members routinely walked in with chairs and blankets. Once people were on the beach, passes were never checked.

Things have gotten even worse now that there are no Park District staff working. Below is the scene at Gillson on Sunday around 5:30 pm. Even at that hour, the parking lots were completely filled — most with cars that had no beach or Village stickers. Worse, drivers were driving recklessly down Michigan Avenue and were flying down the Lake Ave. ramp into the parking lot. (Apparently two police units were deployed to handle parking, but that didn't deter people from speeding into and through the parking lot.)

This level of recklessness cannot continue. It's unsafe. And it's unfair to the many people, residents and visitors alike, who do follow the rules.

I urge the Board, the Executive Director, and the General Manager to brainstorm ways to fix these issues before the season begins next year. (Better signs at beach entrances, more parking enforcement on Harbor Drive, more mature staff patrolling the beaches – all these would help.) This year, we've earned the reputation of the "big, beautiful, anything goes, no rules need be followed" beach. We can't afford that reputation to continue. It's simply too dangerous.

I also urge the Board to fix these problems, through better management of existing crowds and better enforcement of existing rules, before making any "enhancements" to Gillson that will entice even more people to visit, especially if there's lax enforcement.

We have beautiful beaches that, in the past, have always been safe. Let's try to keep it that way.

Re: Proposed improvements for Gillson Park and Elmwood Street Beach

We write concerning the proposed improvements for our lakefront parks. We use both Gillson Park and the Elmwood Street Beach on an almost daily basis and have lived in east Wilmette for fifteen years.

First, Elmwood Street Beach is in desperate need of a new staircase. We use the stairs almost daily and often remark that it is only a matter of time before one of the crumbling concrete steps collapses causing serious injury or even death. This is not an expensive project. It is unfortunate that it was not done last year when the beach was closed for COVID-19 restrictions.

At Gillson, we think the new beachfront bathhouse is both attractive and functional. It has an low profile with minimal visual impact and is quite functional. We appreciate that

a large, unnecessary building was not erected.

The new parking lot, however, was poorly designed and executed. The layout is very inefficient, and the landscaping is both poorly conceived and poorly maintained and is quite unattractive.

We like the green spaces at Gillson as they are now and are strongly opposed to any further construction to erect new or expanded buildings.

Resurfacing the roads and adding sidewalks so that pedestrians do not have share the roadway with drivers would be useful and enhance the safety of the park.

But, please, please do not reduce the open greenspaces at the park for construction of new or enlarged buildings or new parking lots.

We frankly are troubled that the Village would consider making substantial changes to Gillson Park without putting the matter to a vote. Our lakefront parks are one of the principal reasons Alicia and I have remained in Wilmette as empty nesters rather than move to a different community with substantially lower taxes.

Wilmette already has a long list of facilities with meeting and event space. We do not need another.

Please do not ruin a cherished part of our community.

The residents, who are also the taxpayers who fund the District and its operations, have repeatedly requested that Gillson be maintained as it is without new buildings, more concrete, or more parking. We ask you to honor that request and leave Gillson alone, except for necessary maintenance. Gillson is a unique treasure that residents enjoy for its natural beauty and opportunity to commune with nature. We don't want it spoiled.

My husband, children and I have been residents of Wilmette since 1997 and have been fortunate to be able to experience Gillson Park in it's mostly natural state. Development proposals such as Langdon Park Center a few years ago would have been disastrous given the rising lake water levels. Decreasing green space at this time would not be good either. The road into the park is prone to flooding with every heavy downpour, for example.

Subject: [external] Safety at Gillson Beach

Thank you for your time and energy as leaders within our community.

As a formerly elected public school board member and municipal library director, I have tremendous respect and appreciation for your commitment. Thank you also for the collaborative efforts underway to plan for the next generation of Gillson beach lovers.

I was an active participant in the Wilmette Park District as a child, a summer Sports Camp counselor in highschool, a resident over 2 decades ago, and have recently relocated back to Wilmette.

The Gillson Comprehensive Plan identifies the number one Fundamental Principle as "Safety and Security." Unfortunately, the "Existing Conditions Analysis" report did not study or analyze the existing Safety and Security concerns at Gillson.

Residents and Nonresidents alike have free unfettered access to the Lake along the shoreline from the southern border of the Swimming Beach Dune to the northern border of the Dog beach. Efforts to discourage swimming within this area are futile and inconsistent with the Public Trust Doctrine. Complimentary access drives use and overcrowding and further increases safety concerns.

The Park District does not generate any revenue from public use of this area, which would help defray maintenance costs as well as fund improvements, protect the habitat and ensure public safety. However, both the Village and Park District are exposed to significant potential liability in this area.

As you continue the planning efforts for Gillson, perhaps the research could incorporate an analysis of the Safety and Security issues inherent in the actual existing use behaviors and remediation efforts? For example, how successful has the Park District been at limiting swimming in this "non-swimming" zone? What types of safety concerns arise with overcrowding? How did the "Covid" fencing impact use of this area during 2020, and how does the fencing at Langdon Park impact safety? Is there a way to use existing facilities to further promote safety (e.g. might boat racks be relocated and serve as a protective habitat barrier)?

My hope is that the commitment to Safety and Security be honored for the entire riparian area in future proposals of the Comprehensive Plan.

If one of the primary purposes of the park improvements is to create more parking will that be for residents only? What portion of the nonresident fees will pay for the upgrades? Can you furnish a 10 year revenue projection for Lakeview Center, beach daily passes and beach parking based off of the proposed improvements?

I'm not a fan of taking down healthy trees to create space to park. If the trees are unhealthy, or have reached a point where replacing is the best option, then we should do it but not to create more parking.

#### **PAVEMENT**

- RESURFACE OR REPLACE ALL ASPHALT SURFACES, DEPENDING ON CONDITION.
- REPLACE DAMAGED CURBS AND SIDEWALKS. MINIMAL WORK NECESSARY.

#### LIGHTING

- REPLACE EXISTING HIGH-PRESSURE SODIUM LIGHTING WITH DARK-SKY COMPLIANT LED LIGHTING IN A WARM COLOR RENDITION FOR ENERGY EFFICIENCY AND IMPROVED ACCESS TO THE NIGHT SKY.

- SEVERAL PIPES ALONG OVERLOOK DRIVE AND MIDDLE DRIVE ARE FILLED WITH SAND OR SOIL. PIPE OUTFALLS CAN BE CLEARED BY FLUSHING THE PIPE RUN AND/OR CLEARING THE WAY FROM THE PIPE OPENING NEAR THE LAKE TO DRAIN CLEARLY TO OPEN
- THE 2014 VIDEO WORK INDICATED ONE POTENTIAL COLLAPSED PIPE EAST OF LAKEVIEW CENTER, INTERRUPTING THE RUN TO "DAYLIGHT" TOWARDS LAKE MICHIGAN. RE-VIDEO PIPE TO CONFIRM, POINT REPAIRS MAY SUFFICE FOR THE COLLAPSED SECTION, OR A RE-ROUTING OF THE STORM SEWER






