## Wilmette Park District Policy for Public Comment

The Board of Park Commissioners, in its regular or special meetings, is a deliberative body assembled to make decisions on new and pending matters affecting the District. Park Board and Committee meetings are meetings held in public, not a public meeting. The Board invites both oral and written communications from its residents.

To facilitate the conduct of Board/Committee meetings, the following procedures will be followed:

- 1. A section of each regular meeting is set aside for public comment and will be noted on the agenda as "Recognition of Visitors."
- 2. During the "Recognition of Visitors" agenda item, audience members should raise their hands and be recognized by the President/Chairperson prior to speaking.
- 3. When recognized by the President/Chairperson, each audience member should identify themselves and limit speaking to no more than three (3) minutes, unless additional time is granted by the President/Chairperson.
- 4. Questions are to be directed to the entire Board/Committee.
- 5. Park Board members may, by addressing the President/Chairperson, interrupt a presenter to obtain clarification and/or further information.
- 6. A Board/Committee meeting is not a forum for complaints against individual employees. Such matters are handled by directly contacting the Executive Director. Complaints against the Executive Director should be handled by directly contacting the President of the Board of Park Commissioners.
- 7. During presentation and discussion of agenda items, the President/Chairperson will not recognize speakers in the audience unless the Board/Committee desires additional information from an audience member.
- 8. When addressing the Board/Committee, all persons permitted to speak shall confine their remarks to the matter at hand and avoid personal remarks, the impugning of motives, and merely contentious statements. If any person indulges in such remarks or otherwise engages in conduct injurious to the civil discourse of the Board/Committee and the meeting, the President/Chairperson may immediately terminate the opportunity to speak. This decision is at the discretion of the President/Chairperson or upon the affirmative vote of two-thirds (2/3) of the park board commissioners present.
- Any person, except a member of the Board, who engages in disorderly conduct during a meeting, may be ejected from the meeting upon motion passed by a majority of the Board present.

### Dear Executive Director Wilson,

I am writing to request that the Park District immediately rehire Ania Kazakevich as the Head Pro and Manager of Platform Tennis at the platform tennis club.

As a resident and taxpayer in Wilmette, I believe that quality instruction and coaching should be as accessible to the public as to those who are able to join private clubs. After playing paddle at a private club for several years, I chose to join the Wilmette Platform Tennis club for the opportunity to work with Ania. Before taking a break from tournaments, Ania was ranked nationally in the top 10. As players, we benefit from her direct experience in competition and as a result, she has been able to build a very competitive ladies program. Without Ania at the helm, I will not continue league play or membership at Wilmette Park District.

If Ania is replaced with a less skilled and experienced professional, I will be far from the only player to will leave the program. In addition to private clubs, there are numerous public alternatives in Glenview, Winnetka and now Northbrook. This season, I spent more than \$1,300 to belong to the platform tennis club and participate in drills and leagues. There are currently six ladies teams with an average of 10 players each. The park district would forgo at least \$78,000 from the ladies league alone if you are unable to field a successful program due to player departures. Many league players and other North Shore residents also participate in clinics, lessons, in house leagues and social events that, in addition to the men's league, bring significant additional fee revenue to the park district. Without Ania as club manager, there will be little ability to organize these additional revenue generating activities. With the reopening of courts in Illinois's COVID-19 Phase 3, other clubs have begun offering lessons and organized in house match play. Because Ania was laid off, there is no one at the Wilmette Platform Tennis Club to plan these activities. With a significant investment of tax payer dollars to build two additional courts last year, it seems short sighted to risk losing platform tennis fees by eliminating a successful head pro and club manager.

Ania built a program from scratch, gained the loyalty of players and continued to find creative ways to involve members in team building revenue generating programs. She more than repays the investment in her salary every year. With so many competitive alternatives available to our residents through other Park Districts and private clubs, I am very concerned that the program will not continue its success without Ania's leadership. On a personal level, I would also be sad to see a talented coach and teacher forced to seek employment elsewhere.

I ask that the Park District rehire Ania immediately.

#### Dear Steve.

It has come to our attention that you are considering not re-instating Ania Kazakevich as the Head Platform Tennis Pro this fall. We urge you to re-evaluate the value she brings to the program. In our opinion, her merits are manifold:

- Growing the Program: Currently, Ania is waiting for league approval to add teams to the Wilmette portfolio. With 6 courts, Wilmette is often at capacity for team practices and during league play days. And, her continued efforts will help ensure they stay full.
- Growing Revenues: Since Ania's arrival, options for paddle instruction have expanded. Beyond
  collecting dues from the growth of the membership, the Park District has benefited from revenue
  generated by team drills, boot camps, private lessons, and group clinics (such as the newly
  introduced, twice-weekly screen clinics)
- Growing the Program's Stature: Ania's reputation as a top teaching professional is widespread and attracts not only Wilmette residents, but players from surrounding communities (who pay non-resident rates). For example, on our team alone (Series 2) we have 3 players from Winnetka, 1 from Lake Geneva, 1 from Valley Lo and 1 from Chicago. This is consistent with her draw for lessons as well. Part of that stature also comes from her reputation and connection to other teaching professionals. And that connection could be invaluable if COVID affects the start of the fall league-play and programs are forced to re-think how they execute inter-club events.

We realize that COVID has set back many businesses and individuals financially. However, we strongly believe that Ania's leadership and talent more than offset the differential cost you would pay to retain her as the head of the program.

At the request of the Committee, and as discussed at a prior Board of Park Commissioner's meeting, the staff has been requested to outline a recommended process for gathering public input regarding amenities at Community Playfields as negotiated with the Village of Wilmette as a part of the storm water reservoir project.

Attached you will find a rough draft of a survey that would be sent to the community to gather input. The basis for this survey is the survey the District commissioned with an outside consultant regarding the amenities in Gillson Park in 2016. The survey has been converted to be specific to Community Playfields and the items negotiated in the intergovernmental agreement with the Village of Wilmette. At the meeting, the Committee can determine if it wishes to proceed with a survey in this format or in another manner.

In addition to the survey, staff is recommending two public input sessions be conducted in addition to encouraging public input at all future Parks and Recreation Committee and Board of Park Commissioner meetings until final decisions are made. Staff is recommending the two public input meetings be conducted outdoors to encourage as much participation as possible given the varied level of comfort by residents surrounding COVID-19. The meetings would take place in Community Playfields themselves and can be facilitated by staff, the Parks and Recreation Committee, or a Committee of the Whole.

Staff will be seeking board guidance on timing of the survey and public meetings during the discussion at the meeting.

Re: Pool Pricing Analysis

At the request of the Committee, I created the attached analysis of the lap swim pricing. The first 8 columns are data from the online reservation system the public is using to reserve lap lanes. For the columns with the breakdown of resident versus non-resident, through June 30<sup>th</sup>, you see actual numbers. For the days beyond June 30<sup>th</sup>, the resident and non-resident amounts were estimated by me using the 62% resident usage through June 30<sup>th</sup>. As you can see, the overall usage is at 81%.

The next two columns show the revenue for residents at \$16 per hour per reservation and non-residents at \$26 per hour per reservation. You can see the totals at the bottom.

The remaining columns illustrate different pricing and different usage scenarios. Each scenario employs resident pricing of \$10 per hour per reservation while the non-resident rate remains at \$26. Scenario 1 assumes that the non-resident usage remains the same as it has been thus far, but that all the remaining time is consumed by residents, making the overall usage of the available lap lanes 100%. Scenario 2 assumes the same non-resident usage, but 90% usage of the remaining time by residents. Scenario 3 assumes the same non-resident usage, but 85% of the remaining times by residents.

Ultimately, each scenario results in less revenue than our current pricing model. With that said, these three scenarios are simply conceptual, and only scratch the surface of possible concepts for pricing and usage. Therefore, I will have available during the meeting the spreadsheet via my computer to create alternative concepts at the request of the Committee.

Re: Surrounding Communities' Public Pool Survey

At the request of the Committee, below is information regarding what other communities are doing with their public pool operations. Staff will be ready to discuss the information below and any questions regarding the operations at Centennial Family Aquatic Center.

## Glenview

Glenview has two outdoor facilities and one indoor facility. During Phase 4, they opened one of their two outdoor facilities and have announced they are not opening the other nor their indoor facility. In their lap lanes they have a capacity of 16 or 8 at any one time. The difference is driven by other uses of the pool at the same time. They are also allowing up to 100 other people use their facility in 3 time blocks, two are 3 hours long, and one is 2 hours long. Admission requires buying a membership ranging in price from \$84 to \$114 per person depending on membership level and benefits, and then making a reservation. If members do not book all available slot, they are allowing daily admissions for \$11.

## **Des Plaines**

While Des Plaines is a bit further away than our usual surrounding comparison Districts, they do have a public pool in operation so I wanted to include it. They have two outdoor pool facilities. They opened one of them for limited operations. They are providing three, 1.5 hour, public swim sessions per day. Each session has a maximum capacity of 50 people. Their process for obtaining a public swim spot is on a first come first serve basis. People can purchase passes ranging in price from \$65 for a resident individual to \$143 for a family of 5 residents. They are also allowing daily admissions for \$7.50 for residents and \$16.50 for NR to attend public swim on a first come first serve basis.

#### Deerfield

They have 2 outdoor pools and have announced they will be opening one of them on July 6. At the pool they are opening, they are keeping the kiddie pool and slides closed. They are providing three lap swim sessions per day. Each session is 45 minutes long and they are limiting the number of swimmers to one swimmer per lane across their six total lanes. They are also providing two public swim sessions per day that are 2 hours long. Their maximum capacity is 50 people per session and they are requiring advanced registration. Lap swim requires a membership that costs \$75 and their website says they are sold out indicating they capped the amount they sold this year. For public swim they are not using memberships, but are instead selling tickets online to reserve a spot. The tickets can be purchased five days in advance of a session, at a cost of \$9 per ticket, and a maximum of 10 tickets can be purchased for a day per household.

## Other Surrounding Districts

Skokie is planning to open on June 13<sup>th</sup> and have not finalized their capacities and schedule for public consumption. Northbrook and Highland Park are not opening at all this year. Winnetka and Evanston don't have pools. As you go further west past Glenview, many communities stated in April and Maythat they would not open this year. Some have indicated they are reconsidering.
