# Wilmette Park District Policy for Public Comment

The Board of Park Commissioners, in its regular or special meetings, is a deliberative body assembled to make decisions on new and pending matters affecting the District. Park Board and Committee meetings are meetings held in public, not a public meeting. The Board invites both oral and written communications from its residents.

To facilitate the conduct of Board/Committee meetings, the following procedures will be followed:

- 1. A section of each regular meeting is set aside for public comment and will be noted on the agenda as "Recognition of Visitors."
- 2. During the "Recognition of Visitors" agenda item, audience members should raise their hands and be recognized by the President/Chairperson prior to speaking.
- 3. When recognized by the President/Chairperson, each audience member should identify themselves and limit speaking to no more than three (3) minutes, unless additional time is granted by the President/Chairperson.
- 4. Questions are to be directed to the entire Board/Committee.
- 5. Park Board members may, by addressing the President/Chairperson, interrupt a presenter to obtain clarification and/or further information.
- 6. A Board/Committee meeting is not a forum for complaints against individual employees. Such matters are handled by directly contacting the Executive Director. Complaints against the Executive Director should be handled by directly contacting the President of the Board of Park Commissioners.
- 7. During presentation and discussion of agenda items, the President/Chairperson will not recognize speakers in the audience unless the Board/Committee desires additional information from an audience member.
- 8. When addressing the Board/Committee, all persons permitted to speak shall confine their remarks to the matter at hand and avoid personal remarks, the impugning of motives, and merely contentious statements. If any person indulges in such remarks or otherwise engages in conduct injurious to the civil discourse of the Board/Committee and the meeting, the President/Chairperson may immediately terminate the opportunity to speak. This decision is at the discretion of the President/Chairperson or upon the affirmative vote of two-thirds (2/3) of the park board commissioners present.
- Any person, except a member of the Board, who engages in disorderly conduct during a meeting, may be ejected from the meeting upon motion passed by a majority of the Board present.

I've attended the Park Board meetings on the planned stormwater projects and would like to express my support for moving forward on planning. Stormwater issues and solutions have been analyzed for years. It's time to implement actual relief from the near constant threat of flood damage on the westside.

I've attended the Park Board meetings, and I appreciate that residents are able to give input, such as requests for a cross-country ski track, sledding hills, native grass landscaping, and sparing current trees when possible.

However, at the meeting at Community Playfields, a resident objected to any project requiring removal of the cottonwood trees (located at the south edge of the park). Afterwards, he began a "Save the Trees" campaign. But some of his basic assumptions did not ring true.

#### The Cottonwoods

I hope you will take a moment to review my findings, posted on my blog, <u>Sewers of Wilmette</u>. Contrary to the information floating around the village, the cottonwoods are not old growth trees over 100 years old. Instead, they are likely around 65 years old, and are a fast-growing, short-lived tree, commonly used for shade in parks like Community Playfields: <a href="http://sewersofwilmette.com/community-playfields-and-cottonwoods-a-trip-down-history-lane/">http://sewersofwilmette.com/community-playfields-and-cottonwoods-a-trip-down-history-lane/</a>

While it's never great to cut down a tree, I view trees as another element to be managed. And I have full confidence that the parks will be restored to be as good (or better) than they currently are, both environmentally, and for recreation purposes.

#### Contributors to Flooding

One other minor point: Understandably, people who live at the perimeter of the park have special concerns about the appearance and use of each park, but their properties very likely contribute to the problem. What people forget is that water seeks the most permeable surface,

and the lowest level. Wilmette has approved construction of increasingly big home footprints throughout the westside, thus reducing permeable land area, without increasing stormwater management capacity. In addition, climate change is bringing more intense rainfall. The result is wet and unusable park fields, and flooding of streets and properties. It's irresponsible to do nothing or to pretend it's somebody else's problem.

#### Intra-Governmental Agreement

I know that the Park Board plays a specific role in the community. But to a westside resident, the Village and Park are intertwined with daily life. At the moment, it's difficult for many of us to "move on" knowing that, at any time, during each rainy season, we could face tens of thousands of dollars in home damage, not to mention lost work time and health issues, due to a simple lack of basic infrastructure.

Thank you for moving forward with an intra-governmental agreement as quickly as possible so the stormwater projects can begin as planned.

#### Langdon Park

Staff continues to monitor the erosion to the beach bluff areas, which changes drastically from day to day. We will continue to provide safe passage down the bluff to the beach area. If the bluff deteriorates, we will install signage and fencing to block access to those areas.

#### Tot-Lot

Parks maintenance staff removed the bark chips from the tot-Lot. The chips were installed in December to allow for use of the playground over the winter until warmer weather allowed for the installation of the poured in place rubber safety surface. The contractor returned to install the new surface but was delayed by the rainy weather. The play area was closed for 17 days and reopened May 9<sup>th</sup>. The contractor will be back, weather permitting, to install the remainder of the landscaping and drinking fountain.

#### **Golf Clubhouse**

Building Services completed installation of the new roof top unit that serviced the dining area. The original unit had a bad heat exchanger and a leak in the evaporator coil. With the age of the unit and obsolete R-22 Freon, replacement was a better option than repair.

### **Golf Course**

Building Services repaired the pond overflow basin. The extension ring was cracked and a feeder pipe was broken causing the pond to drain down below fill level. The extension ring was repaired and a new section of pipe was installed. The system is now working properly.

# **Centennial Pool**

Building Services is preparing the aquatic center for the upcoming season. Pools have been power washed and repairs made to lane markers on the bottom of the pool. The winter cover was removed from the diving well and new padding, along with new diving board stanchions have been installed. Water has been turned on to deck fountains and spigots and repairs have been made to two hydrants. PA system speakers have been

checked for operation and repaired or replaced where needed. Locker rooms were cleaned and spot painted and plumbing fixtures were assembled and tested.

# Gillson Park Lakefront Project

Weather has had a major impact on the completion of the parking lot and some of the exterior components. All the curbs for the parking lot and roadways have been installed and the stone subbase has been put in place and finished graded. Weather has delayed the installation of the asphalt binder course but weather permitting, should be installed by May 11. Parking area lighting is installed and working, and pathway light bollard foundations are in place and the fixtures will be installed this week. The Michigan Ave. sidewalk and bike path will be completed this week weather permitting. Trees in the parking lot have been installed in bio swales and the rest of the plantings will take place after May 15th, due to the possibility of frost that would void the warranty on the plants. All utilities to the new beach house are in place and working. The concession stand is complete and has received construction inspection from the Village sanitarian. Men's, women's and family changing bathrooms are 95% complete and are waiting for stall dividers and windows to be installed. Administration building has windows installed and all interior wall finishes are complete. Millwork should arrive this week. The exterior trellis will be finished by the end of the week if the weather cooperates. Carpenters have finished the framing portion of the two wood decks and have begun installing deck boards. Weather has caused delays this spring but our construction manager is confident we will be open on time with just landscaping to be completed. Dune/security fence for the swimming beach has been installed.

- Remaining snow fence was removed from the sailing beach
- Field lines were painted at all Lacrosse, Soccer and Baseball fields
- Monthly tot-lot inspections were completed and repairs made to CRC and Hibbard Park tot-lots
- Assisted golf course staff with chipping tree branches from spring tree trimming
- Prepared softball fields at Howard Park, Central School and McKenzie for upcoming season
- Made repairs to irrigation system at Lakeview Center that was damaged by the installation of electric piping for the new building
- Installed permanent drainage piping at Gillson Park Tot-Lot and Wildflower garden reading circle
- Repaired stone wall at skate park, and brick steps and handrail at Mallinckrodt Park sidewalk stairs
- Core aerated and over seeded turf areas at outdoor ice rinks and sports fields at Community and Avoca playfields

- During heavy rainfall period, assisted Lakefront contractor to pump storm water out of low lying parking areas to facilitate the installation of stone base for roadways and parking areas
- Drinking fountains and water spigots at the community gardens were assembled and turned water on for summer
- Assembled and located new picnic tables for the picnic areas at Gillson Park
- Removed stumps at all park locations where winter storm damage had fallen trees; backfilled and seeded those areas

# **Building Services Work**

- Installed water piping to the whale at Gillson Beach
- Installed new piping to beach light poles to accommodate wiring of beach PA system
- Made repairs to electric service to sailing shack; the line was cut several times during construction

# **General Administration Operations Report**

#### Month End March 31, 2019 Financial Results – Narrative

As of March 31, 2019, combined revenue is higher than year-to-date budget in all revenue categories. Daily Fees, Rental Revenue, Retail Sales and Miscellaneous Revenue are at or near budgeted targets as of March 31. Property Tax collections, Fee Revenue and Membership Fees exceeded their revenue targets by a greater margin than expected. Departments throughout the District have shown an increase in 2019 winter programming. In addition, increases in the aforementioned areas are due to higher than anticipated camp registration and completed payments made toward camp activities. This resulted in operating revenue trending higher than budgeted.

Combined operating expenses are lower than budget by 8% across all categories.

The District is showing a surplus from Operations of \$7.3 million and an overall surplus of \$6.1 million.

The District 2019 revenue compared to 2018 is higher by 1% and operational surplus compared to 2018 is higher by 2%. Property Tax Revenue has evened out year over year. In the first 2 months of 2019, Property Tax Revenue was lower year over year due to the effect of the Tax Cuts and Jobs Act of 2017. The reason for the decrease was due to a majority of Wilmette residents paying their 2017 property tax bill before the end of calendar year 2017. The law applied a property tax deduction cap of \$10,000 for taxes paid in calendar year 2018. Therefore, we received an abundance of property tax revenue earlier than we anticipated.

The Lakefront Infrastructure/Beach House project expenditures totaled 96% of total capital expenditures as of March 31. With an anticipated completion of mid to late May, expenditures will ramp up over the next several months towards the project. As of March 31, capital spending is lower than the 2019 budget by 45%.

# <u>Customer Service, Information Technologies and Finance</u>

In February, IT staff managed the setup of email encryption for the District. In addition, staff renewed and updated the Apple mobile device management certificate. Finally, staff updated the District's financial software (Tyler-Incode).
