WILMETTE PARK DISTRICT MILITARY DISCOUNT POLICY

Purpose:

Wilmette Park District recognizes and appreciates those residents who currently serve within the branches of the United State military, including those reservists on active duty. The District also recognizes the sacrifice that military personnel and their families make to serve and protect our country. It is vitally important that these individuals and their families have affordable, active recreational services available to them in order to maintain training levels, live a healthy lifestyle and provide ample opportunity for family time while committed to serving our country. **To these ends the Board of Park Commissioners establishes an overall policy to provide discounted rates to military personnel and their families.**

Definitions:

Active Military - Individuals who are on active status within a branch of the United States military (Army, Navy, Air Force, Marine Corps and Coast Guard), active Army National Guard and any reservists called to duty.

Resident - Individuals and families living within the geographic boundaries of the Wilmette Park District.

Discount Policy:

Discounts are available for Park District provided programs and services:

- 20% total discount on all programs offered by the Wilmette Park District. Please note the list of excluded programs and services.
- 20% total discount of any contractual programs subject to the review and approval on a case by case basis.
- 20% off Daily Fees at Centennial Family Aquatic Center, Wilmette Beaches, Center Fitness Club, Centennial Ice Rinks, Wilmette Tennis Club, Wilmette Golf Club and Wilmette Platform Tennis Club.

- 20% off Beach, Pool, Fitness, Ice, Tennis, Dog Beach and Golf Memberships.
- Two for one discount for any ticketed performance by the Park District Adult and Children Theater.

The following programs and services are excluded from the above listed discount benefits for eligible military residents and family members.

- Private or group golf, tennis, platform tennis, sailing and ice skating lessons.
- Fitness personal trainers.
- Facility rentals, including Birthday Parties.
- Food and beverage at any of the Park District facilities.

Other Considerations:

In establishing the above policies for military discounts, the Park District considered the following procedures:

- Proof of active status (military orders) must be provided at the time of registration in order for the discounts to be applied.
- Eligible individuals must be residents of the Wilmette Park District. Proof of residency must be provided at the time of registration.
- Family members with proof of military status are eligible for the discounts and must also be residents of the Wilmette Park District
- Family members are defined as. spouses and children of the military personnel who live within the same household within the geographic boundaries of the Wilmette Park District. Outside of the Wilmette geographic boundaries, this privilege is extended to family members of Kindergarten through Grade 8 students living in the geographic boundaries of Wilmette Public School 39 or Avoca School District 37.
- Individuals and family members assigned to active duty at the Wilmette Coast Guard Station.
